# **External root resorption: Arrested or progressing?**

# Abstract

External root resorption may be an uncontrolled phenomenon, and the most known interventions have no effect. Even progressive external root resorption may not be controlled by long term Ca(OH)<sup>2</sup> therapy. Currently, there are no treatment options for vital tooth that suffer from root resorption. This invasive resorption can lead to extraction of the tooth. The use of new technologies such as low power laser may control this type of resorption. (Iranian Endodontic Journal 2008;3:93-4)

## Core of idea

External root resorption is an inflammatory reaction that is progressive because of a present or past traumatic injury, or an unknown cause (1-3). Also some dental treatments such as orthodontics or bleaching lead to external root resorption. In some teeth with necrotic pulps, intra canal medicaments such as Ca(OH)<sub>2</sub> have been shown to have moderate healing effects. Vital teeth that undergo resorption process have two popular treatment options:

1- intervention with intra canal medicaments indipendent of tooth vitality

2- Monitor the resorption process.

Intra canal medicament is not ideal because of uncertain results in vital teeth.

Low power lasers have been shown to have good effects on controlling proliferation and migration of inflammatory cells to the site and can be used only over the area without any serious manipulation (4,5). It is obvious that use of some materials or stains for example methylen blue could improve the therapeutic effect of laser. On the other hand, it seems that dentinal tubules act as fiber optic paths that conduct laser beams to the resorption area increasing the localized effect of the laser. This phenomenon is similar to some irrigants that increase the diffusion of hydroxyl ion over the dentin, in exposed canals.

We hypothesise that the use of this technology immediately after treatment plans such as bleaching or orthodontics may control unwanted side effects ie, root respition. Use of low power laser may be effective even after beginning of this destructive process.

# What is cheating?

Although cheating means "giving or receiving information during an exam" but it is interpret as "Writing a paper for another colleague or asking someone to write a paper for you". Also it means submitting the same paper-or different versions of the same paper for more than one journal.

### What is plagiarism?

According to the oxford English Dictionary, "To plagiarize"means: "To take and use as one's own the thoughts, writings or inventions of another." In other word this include both the theft of un written ideas and concepts as well as the theft of written texts, notes, designs, and/or visual materials. In many countries original ideas are considered intellectual property and are protected by copyright laws.

#### Types of plagiarism:

1-Use of any amount of another's words, without a citation or with improper citation.

2-Use of another's words with false citation and/ or the use of deceptive or fabricated citation to avoid direct plagiarism.

3-Use of any amounts of other's words with proper citation but without quotation marks is still plagiarism. Alteration of a text (but not the author's idea) eliminate the need for quotation marks but you have not eliminated for an explanatory citation.

4-Use of any amount of txt that has been improperly paraphrased.

5-Use of any amount of text, that is properly paraphrased but which is either not cited or improperly

### <u>Do not</u>

- The actual words or idea of another use the following pieces without proper acknowledging the source:

- A paraphrase of the words or ideas of another
- Illustrative material creating by another
- Facts, statistics, or any other information that is not common knowledge
- **Do not** rearrange words, phrases or sentences without proper citation.
- **<u>Do not</u>** substitute synonyms for other's words.
- **Do not** paraphrase information in a way that changes its meaning.

**Do not** cite sources that not used.

**Do not** purchase a paper from a website or another person and submit it as your own.

**Do** proper acknowledge the source of any quotations, paraphrase ... etc.

**Do** place quotation marks around other's words. **Do** develop your own writing style.

**Do** learn how to detect and prevent plagiarism.

When a paper has been wrote in a distinctly different style you can suspect that a plagiarism constituted, then in review of articles or for self control of your paper, you can use online websites or softwares like as:
