## **APEC News**

Asian Pacific Endodontic Confederation (APEC) is an international (regional) association of endodontists from countries in the Asian Pacific region. According to the confederation, APEC tries to develop and maintain high standards of endodontic research/teaching and practice and build closer professional relationships of endodontists within the target region.

Foundation of APEC backs to the 30 years ago, when the first meeting was held in December 1985 in Bangkok, Thailand. Actually, the idea of organizing an endodontic group in the Asian Pacific region had its beginnings through the efforts of several dedicated individuals and determined spirit of international cooperation and sharing.

In April 1985, during the Annual Convention of the American Association of Endodontists (AAE) held in San Diego, California, Dr. Miyahara and Dr. Vizcarra met to conceive the idea of forming a group of endodontists in Asia. They drafted the initial Constitution and by-laws of an organization of endodontists in Asia as a division of the International Federation of Endodontic Associations (IFEA). The drafted by-laws were patterned after IFEA; even they initially named it as Asian Federation of Endodontic Associations (AFEA).

The first organizational meeting was held on December 1985, in Bangkok, Thailand, where, in an informal election, Dr. Ernesto R. Vizcarra of the Philippines was elected as President. Hong Kong, Philippines, Thailand, Singapore, Bangladesh and India were the participating countries. Australia and New Zealand later joined the APEC.

One year later, on November 12, 1986, during the 74<sup>th</sup> FDI World Dental Congress held in Manila, the second organizational meeting was held at the Mindoro Room, Philippine Plaza Hotel, Manila, Philippines. The name of the organization adopted at that meeting was the Asian Pacific Endodontic Confederation (APEC). The approved constitution and by-laws was ratified and adopted in 1988 during the first biennial Meeting held in New Delhi, India, in 1998-99.

During the incumbency of Dr. Paul V. Abbott as the APEC president,, the constitution was revised to reflect changes in the methods of operations of the confederation and the increasing number of Endodontic society/association Members (national

endodontic societies/associations from within the Asian Pacific region). It was presented and adopted at the biennial meeting held in April 1999 in Singapore.

In the 1993 Newsletter, the President of APEC, Dr. John Booth of Australia, added the following reasons why endodontists and the national endodontic societies should join APEC and continue to support its activities: to keep their country involved in regional endodontics, to promote their country in the newsletter by way of articles on Endodontics, to work towards achieving high quality endodontics by means of advancing education through attending the meetings, to set up a sight for board-registered members of endodontists in their country-which could be of value if they have patients traveling in the Asian Pacific region, to receive the newsletter and keep in touch.

As a non-profit organization and to formalize its legal existence, APEC was registered in November 1989, with the "Registry of Societies" in Hong Kong.
